Between our outreach during the June Primary and November General election, ACCEs paid canvass and member volunteer teams reached out to a combined total of 33,479 voters! Of those we outreached to, 9,300 said they were impacted by housing issues - many of which opted into both phone and email communications from us. As the election cycle closed, ACCE offices and organizers began immediately following up with these contacts to bring them into our organizing campaigns beyond the election cycle. Additionally, for the first time ever, ACCE hosted Electoral Deep Dive Debriefs for members throughout the year to talk about why elections matter, understand the electoral landscape in our cities and geographies, discuss our strategy for building electoral power for our people, look at our past wins, and understand how to get out the vote. Between our electoral deep dive debriefs in February, May and July - over 50 members participated.
