SHE-CAN stands for Supporting Her Education Changes A Nation and our mission is to equip and empower young, low-income women from post-conflict countries to become leaders who change their nations and the world. SHE-CAN believes women's global leadership is a solution to many of the insurmountable issues overwhelming our planet: climate change, clean water, war, etc. These issues disproportionately impact women and yet, most leaders addressing these issues are men. To solve these problems, women need to sit at all local, domestic and international decision-making tables. We address this need by giving potential leaders the opportunity to gain the world-class tertiary education, leadership training, and mentorship needed to break from oppressive systems. Scholars are prepared to return to their communities as impactful leaders ready to launch careers that allow them to take their seats at leadership tables and promote more just, peaceful, and inclusive practices.

In 2011, SHE-CAN began recruiting scholars from Rwanda. By 2014, the organization had expanded into Cambodia, and in 2018, recruited the first class of scholars in Liberia. Most recently, SHE-CAN expanded into Guatemala in 2021. To date, 83 scholars have won over \$21M in scholarships to American colleges and universities. SHE-CAN saw an opportunity to engage U.S. schools as partners and in 2015 formed the SHE-CAN Scholarship Coalition, comprised of a group of 13 partner schools who have each committed to award annual full scholarships to SHE-CAN candidates. SHE-CAN targets only low income, high potential scholars who lack access to opportunity. Scholars currently attend a total of 30 schools including Dartmouth, Georgetown, and University of San Francisco. Additionally, twenty new candidates from Cambodia, Liberia, and Guatemala have been selected and are applying for 2023 admittance. Each scholar in the program is matched with a team of 5-6 mentors and today there is a deep pool of over 376 impressive and powerful mentors. These mentors help their scholar navigate the college application processes, support her emotionally, academically while she is in school, and provide valuable networking resources to help her establish her career once she returns home. SHE-CAN provides in-country SAT test preparation and funds all non-scholarship costs such as plane tickets, computers, books, health insurance, phones, dormitory supplies and winter wardrobes. SHE-CAN's 46 program graduates are thriving in impressive careers and several are already leaders, including the Minister of State at the Rwandan Ministry of Infrastructure, a Program Manager at a Cambodian clean energy company, and the Advisor to the Rwandan Minister of Trade and Industry. Given their success, SHE-CAN plans to scale into new markets in the coming years.
