IMPACT INVESTING SERVICES - THROUGH ITS IMPACT INVESTING PORTFOLIO, SFI DEVELOPS AND MANAGES IMPACT-FIRST INVESTMENTS AND INNOVATIVE FINANCING SOLUTIONS THAT GENERATE POSITIVE OUTCOMES FOR PEOPLE AND COMMUNITIES. AS AN INTERMEDIARY, SFI WORKS IN COLLABORATION WITH ITS PARTNERS TO DESIGN, LAUNCH, AND MANAGE IMPACT INVESTMENT PROJECTS. ITS PARTNERS INCLUDE FEDERAL, STATE AND LOCAL GOVERNMENTS SEEKING TO DEPLOY PUBLIC FUNDS TO ADDRESS LONG-STANDING SOCIAL ISSUES, WITH A FOCUS ON OUTCOMES, AND, IN SOME CASES, BY LEVERAGING PRIVATE IMPACT INVESTMENT FUNDS. SFI'S IMPACT INVESTMENTS ARE STRUCTURED EITHER THROUGH EQUITY OR LOAN FINANCING STRUCTURES. CAREER IMPACT BONDS ("CIBS"), A DISTINCT CONTRACTING STRUCTURE BASED ON DEFERRED TUITION AGREEMENTS LIKE INCOME SHARE AGREEMENTS OR OUTCOMES BASED LOANS IN WHICH IMPACT INVESTORS' FUNDS COVER UPFRONT PROGRAM COSTS AND CRITICAL WRAPAROUND SUPPORT SERVICES FOR LOW INCOME, UNDER SKILLED, OR UNDER EMPLOYED STUDENTS IN ORDER TO ADVANCE THEIR ECONOMIC MOBILITY.
