FREEDOM'S JOURNAL INSTITUTE BEGAN HOSTING THE BCS IN 2013. WE HOSTED FOUR OF THEM BEFORE COVID. WE BELIEVED WE SHOULD DO IT AGAIN. ONE OF OUR MAIN OBJECTIVES WAS TO LET BLACK CONSERVATIVES REALIZE THEY WERE NOT ALONE, THUS MAKING IT EASIER TO SPEAK OUT ON ISSUES THAT CONCERNED US MOST. SECOND WAS TO MAKE IT EASIER FOR BLACK CONSERVATIVES TO COME OUT OF THE CLOSET, SPEAK OUT, AND VOTE FOR THEIR VALUES.
