We provide website resources, trainings, webinars, newsletters, produce the annual National Wilderness Workshop, and provide funding through challenge cost shares with the US Forest Service.

NWSA supports wilderness stewardship groups across the country with funding opportunities, mentoring, and assistance developing partnerships and working with land management agencies. NWSA's US Forest Service challenge cost share program helps organizations build capacity for public land stewardship.

NWSA offers many on-line and digital resources, including toolkits for stewardship organization start-up, sharing of best practices, grant writing, and actions affecting wilderness stewardship. NWSA curates a monthly wilderness newsletter and hosts webinars to connect and educate the wilderness stewardship community. We also offer small grants, sourced from endowment funds, to assist new wilderness stewardship groups with start-up costs.

NWSA co-hosts the annual National Wilderness Workshop, a national gathering of volunteers, stewardship groups, academics, and land management agency professionals to connect the wilderness stewardship community, share best practices, keep current with conservation science, learn from experts and each other, and develop scalable solutions to issues affecting wilderness management and stewardship.
