The agency assisted 8,433 clients with legal problems, including providing legal advice and representation regarding health issues, public benefits, consumer issues, housing, foreclosure prevention and pensions. This program utilized \$26,608 of donated services.

Agency long-term care ombudsmen provided information and assistance with 10,749 issues and problems related to long-term care, including care plans, abuse, restraints, lost or stolen belongings, quality of care, misappropriation of funds, transfers and discharges, and long-term care facility selection. This program utilized \$23,494 of donated services.

The agency's Ohio Medicare Patrol (SMP) team members participated in 311 group outreach and education events, reaching 26,112 individuals. Volunteers for SMP provided over 182 hours of service to educate seniors about taking an active role in the detection, prevention and reporting of health care errors, fraud and abuse. This program utilized \$4,908 of donated services.
