LEDA SCHOLARS PROGRAMASPECTS OF LEADERSHIP SUMMER INSTITUTE: COHORT 18 ATTENDED THE ASPECTS OF LEADERSHIP SUMMER INSTITUTE IN-PERSON AT PRINCETON UNIVERSITY. LEBA SCHOLARS RECEIVED WRITING INSTRUCTION, LEADERSHIP DEVELOPMENT, TEST PREPARATION, COLLEGE GUIDANCE, AND MULTIPLE COMMUNITY BUILDING ACTIVITIES. THE INSTITUTE ALSO FEATURED IN-PERSON PRESENTATIONS BY ADMISSIONS REPRESENTATIVES FROM SEVERAL COLLEGES AND UNIVERSITIES, INCLUDE COLLEGE CAMPUS VISITS. THE SUMMER INSTITUTE DEVELOPS SCHOLARS' LEADERSHIP SKILLS, STRENGTHENS ACADEMIC WRITING AND CRITICAL THINKING SKILLS, BUILDS A LASTING SCHOLAR COMMUNITY, AND PREPARES SCHOLARS TO APPLY TO HIGHLY SELECTIVE COLLEGES. RECRUITMENT AND ADMISSION:IN FISCAL YEAR 2022, RECRUITMENT EFFORTS SPANNED ALL 50 U.S. STATES AND WASHINGTON D.C. STAFF CONDUCTED VIRTUAL AND IN-PERSON INFORMATION SESSIONS AT NEARLY 100 HIGH SCHOOLS THROUGHOUT THE COUNTRY, SPEAKING TO HUNDREDS OF STUDENTS AND CONNECTING WITH DOZENS OF COMMUNITY-BASED ORGANIZATIONS. LEBA RECEIVED AN AVERAGE OF 1,300 APPLICATIONS, ADMITTING 102 STUDENTS FROM 36 STATES THROUGHOUT THE COUNTRY. THE AVERAGE HOUSEHOLD INCOME FOR INCOMING COHORT 18 SCHOLARS WAS \$36,500 AND 87% ARE FIRST-GENERATION COLLEGE STUDENTS REPRESENTING DIVERSE RACIAL AND ETHNIC BACKGROUNDS.COLLEGE GUIDANCE:LEBA SCHOLARS RECEIVED IN-DEPTH ADVISING ON THE COLLEGE APPLICATION PROCESS STARTING AT SUMMER INSTITUTE AND CONTINUING THROUGH THE ACADEMIC YEAR. LEBA STAFF PROVIDED ONE-ON-ONE COUNSELING SESSIONS WITH SCHOLARS, INDIVIDUALIZED RECOMMENDATION LETTERS, FINANCIAL AID AND SCHOLARSHIP APPLICATION ASSISTANCE, AND SUPPORT WITH COMPLETING COLLEGE ESSAYS. COHORT 17'S MATRICULATION RATES WERE AS FOLLOWS: 97% WERE ADMITTED TO A MOST COMPETITIVE COLLEGE, WITH 88% MATRICULATING, AND 57% WERE ADMITTED TO AN IVY LEAGUE INSTITUTION, MASSACHUSETTS INSTITUTE OF TECHNOLOGY (MIT), OR STANFORD UNIVERSITY. COLLEGE SUCCESS:OVER THE COURSE OF FISCAL YEAR 2022, LEBA'S COLLEGE SUCCESS PROGRAM PROVIDED SUPPLEMENTAL ACADEMIC ADVISING AND SOCIAL-EMOTIONAL COUNSELING SUPPORT TO FIRST YEAR COLLEGE STUDENTS, RETURNING STUDENTS, AND GRADUATING SENIORS IN COLLEGE. LEBA ALSO SHARED LEADERSHIP DEVELOPMENT OPPORTUNITIES AND COLLEGE COMPLETION RESOURCES, PROVIDED EMERGENCY GRANT ASSISTANCE AND POST-GRADUATE PLANNING SUPPORT, ORGANIZED COMMUNITY-BUILDING ACTIVITIES, AND SUPPORTED FIRST-YEAR SCHOLARS WITH PEER MENTORING SUPPORT SERVICES. STAFF CONDUCTED 585 FORMAL CHECK-INS; SCHOLARS WERE VISITED THROUGH FORMAL AND INFORMAL CAMPUS VISITS; AND LEBA'S PEER MENTOR PROGRAM HAS ONE OF ITS MOST SUCCESSFUL YEARS YET, WITH 178 FIRST-YEAR COLLEGE STUDENTS OPTING INTO THE PROGRAM, MORE THAN DOUBLE FROM THE PRIOR YEAR.

LEBA CAREER AND ALUMNI SERVICESIN FISCAL YEAR 2022, LEBA'S CAREER AND ALUMNI SERVICES TEAM PREPARED HIGH-ACHIEVING, LOW-INCOME UNDERGRADUATE STUDENTS FOR FUTURE LEADERSHIP ROLES, INCLUDING A DEEPER AND MORE TARGETED FOCUS ON CAREER EXPLORATION, PROFESSIONAL DEVELOPMENT, AND CAREER COACHING. THE LEBA CAREER NETWORK INCLUDES A FLAGSHIP FIVE-DAY CAREER INSTITUTE. IN 2022, THE LEBA CAREER INSTITUTE RETURNED TO NYU LAW FOR AN IN-PERSON DEBUT.
