THE COLLOQUIUM MODEL DRAWS ON THE EXPERTISE OF HISTORIANS, EDUCATION SPECIALISTS, AND MASTER TEACHERS, AND EMPHASIZES THE GOALS AND PRIORITIES OF THE TEACHERS SERVED. IN 2019, THE US DEPARTMENT OF EDUCATION AWARDED NCHE A PRESIDENTIAL AND CONGRESSIONAL ACADEMIES FOR AMERICAN HISTORY AND CIVICS GRANT, TO PROVIDE INNOVATIVE PROFESSIONAL DEVELOPMENT IN AMERICAN HISTORY, CIVICS, GOVERNMENT, AND GEOGRAPHY FOR TEACHERS IN THE SCHOOL DISTRICT OF OSCEOLA COUNTY, FLORIDA OVER THE COURSE OF THREE YEARS.
