Community Organizing: JCUA partners with community-based organizations on a grassroots level to bring about systemic change. Current organizing campaigns and coalitions in which JCUA is involved are focusing on housing and homelessness, community safety, and immigration justice. JCUA's commitment to combatting racism and antisemitism are priorities within this work.

4b (Code:) (Expenses \$ 172,366 including grants of \$) (Revenue \$)
Youth Engagement: The Or Tzedek Teen Internship and College-aged Fellowship year-long programs train youth in the JCUA model of addressing systemic issues of inequality from a root-cause approach; strengthening civic engagement as a core aspect of Jewish identity; and providing youth with community-organizing skills. Through the programs, youth deepen their identities as compassionate and civically engaged leaders.

Community Investment: JCUA's Community Ventures Program provides zero-interest pre-development loans for affordable housing, economic development, and job creation projects across this city. Individuals and institutions participate in this program through granted and loaned funds to the revolving loan fund. Funds are made available through an application process as zero-interest loans primarily to nonprofits.

Basebuilding: JCUA works to deepen the strategic impact of its members and grow the base.
