THE NORTHEAST ENTREPRENEUR FUND (EF) PROVIDES SMALL BUSINESS SERVICES AND LOANS TO BUSINESS OWNERS AND ASPIRING ENTREPRENEURS IN ITS 17 COUNTY SERVICE AREA OF MINNESOTA AND WISCONSIN. IN 2022, TOTAL PROGRAM COSTS OF \$5,711,590 WAS EXPENSED TO PROVIDE SERVICES TO 1,617 ENTREPRENEURS. 327 LOANS WERE DISBURSED TO THOSE CLIENTS TO START, STABILIZE OR EXPAND THEIR BUSINESSES. A TOTAL OF \$24.5 MILLIONS IN LOANS WERE APPROVED. A MAJORITY OF THOSE WERE DISBURSED TO LOW-INCOME INDIVIDUALS OR IN LOW-INCOME COMMUNITIES.
