2022 was another big year for trails in Idaho. With the help of 754 volunteers, ITA organized 68 projects in diverse geographic locations, from incredibly remote places, to trails just outside Boise and Sandpoint, ranging from one-day projects to weeklong trips. The projects completed were all based on public lands throughout the state. After hikes to the project sites, ITA crews worked a total of 11,799 hours, cleared 280 miles of trail, removed 4,446 logs, cleaned 510 water bars, fixed 24,785 feet of tread, and brushed 71 miles of trail. The ITA hosted five Women's Only Weekends (WOW) and seven Youth only projects.
