THE FOUR ISSUES OF YOUNG CHILDREN CONTAINED CLUSTERS OF ARTICLES ADDRESSING THE FOLLOWING TOPICS: DAP AND PLAYFUL LEARNING; PREPARING EARLY CHILDHOOD EDUCATORS; INDIVIDUALITY AND INCLUSIVE PRACTICES; SUPPORTING LITERACY THROUGH ENGAGING INSTRUCTION AND MATERIALS.

IN NAEYC'S FISCAL YEAR ENDING AUGUST 31, 2022, NAEYC HOSTED ITS SECOND SUCCESSFUL VIRTUAL ANNUAL CONFERENCE (NOVEMBER) THAT DREW OVER 3,700 EARLY EDUCATION PROFESSIONALS AS THEY GATHERED TO LEARN, CONNECT, AND GROW AS A PROFESSION. THE CONFERENCE ALSO FOCUSED ON THE RELEASE OF NAEYC'S FOURTH EDITION OF DEVELOPMENTALLY APPROPRIATE PRACTICE IN EARLY CHILDHOOD PROGRAMS. NAEYC'S PUBLIC POLICY FORUM ALSO TOOK PLACE VIRTUALLY WITH MORE THAN 1,300 EARLY CHILDHOOD EDUCATORS AND ADVOCATES FROM ALL 50 STATES AND THE DISTRICT OF COLUMBIA PARTICIPATING IN TWO DAYS OF MORE THAN 20 ONLINE, INTERACTIVE, AND RECORDED SESSIONS FEATURING FEDERAL, STATE, AND LOCAL ECE POLICY EXPERTS AND LEADERS, FOLLOWED BY MULTIPLE DAYS OF VIRTUAL VISITS WITH CONGRESSIONAL MEMBERS AND STAFFERS.
