OUR GOOD MEALS FOOD SERVICE PROGRAM AT THE GOODWILL INN PREPARES ABOUT 166,800 MEALS A YEAR FOR PEOPLE EXPERIENCING HOMELESSNESS, PEOPLE IN RECOVERY, AND SENIORS IN NMCAA'S MEALS ON WHEELS PROGRAM.

OUR OUTREACH PROGRAM LOCATES AND ENGAGES PEOPLE EXPERIENCING UNSHELTERED HOMELESSNESS WHERE THEY ARE TO OFFER HELP FINDING SAFE AND SECURE HOUSING. THE GOODWILL INN PROVIDES SAFE, SUPPORTIVE TEMPORARY EMERGENCY SHELTER FOR ADULTS AND FAMILIES EXPERIENCING HOMELESSNESS. CARSON SQUARE PERMANENT SUPPORTIVE HOUSING PROVIDES SAFE, SUPPORTIVE HOUSING TO THOSE EXPERIENCING HOMELESSNESS, PEOPLE WITH SPECIAL NEEDS, AND VICTIMS OF DOMESTIC VIOLENCE USING PROJECT-BASED HOUSING VOUCHERS. PATRIOT PLACE PROVIDES TRANSITIONAL HOUSING FOR VETERANS EXPERIENCING HOMELESSNESS. OUR HOUSING-BASED CASE MANAGERS PROVIDE SUPPORT TO PEOPLE ONCE THEY MOVE INTO HOUSING TO HELP THEM MAINTAIN LONG-TERM HOUSING STABILITY. OVER THE COURSE OF THE YEAR, 1,000 PEOPLE WERE HELPED BY THESE SERVICES, 30,942 NIGHTS OF SHELTER WERE PROVIDED, AND 288 FAMILIES AND INDIVIDUALS MOVED FROM HOMELESSNESS INTO HOUSING.
