TO DATE, MANO A MANO AVIATION HAS PROVIDED MORE THAN 4,543 PEOPLE WITH EMERGENCY FLIGHTS. THE MAJORITY OF MANO A MANO'S FLIGHTS SERVE THE DEPARTMENT OF BENI IN THE AMAZON REGION OF BOLIVIA.
