Step Ahead: This program connects with street children through nightly outreach; reunites them with their families when possible; and supports them with comprehensive services including counselling accommodation meals material support life skills development and school fee relief. In 2022 the program met and assisted 232 children on the streets of Hanoi and reunited 75 of them with their families. We assisted 183 children to go to school 25 to attend vocational training and 30 to get a job. Total beneficiaries in 2022: 439

Legal Department: Blue Dragon's Legal Advocacy department advises and represents children and young adults in crisis who need legal assistance. Services include the rescue and repatriation of people who have been trafficked and enslaved; assisting people in obtaining legal registration papers; training police border guards and officials to combat human trafficking; and advocating for the reform of laws and policies to better protect all children. In 2021 the Legal department coordinated the rescue and safe repatriation of 225 victims of human trafficking Our lawyers represented 28 victims of trafficking in court cases resulting in the conviction of 46 traffickers. We provided individual legal advice and information for over 90 children survivors and families. Total beneficiaries: 300

Project X: Provides emergency and long-term psychosocial support for female survivors of sexual exploitation and trafficking. During 2022 the program provided emergency assistance and emergency accommodation for 128 female victims and long-term psychosocial care for 67 survivors. We assisted 38 survivors and their children to return to school and helped 33 adult survivors to get a job. Total beneficiaries: 195
