1 Briefly describe the organization’s mission:

Providence Student Union worked throughout the year to build student power so that young people could improve their education and well-being. Program activities included the organization's campaign to reform school staffing practices with the demand of removing school resource officers and expanding access to nurses, mental health workers, social workers, and guidance counselors in school. PSU also supported efforts to increase the need for an accurate culturally relevant curriculum in the district through their ethnic studies campaign state support for school infrastructure improvements and to build awareness of the lack of civics education in Rhode Island schools.

Providence Student Union (PSU) worked to build student power so that youth in Providence could improve their education and well-being. Key program activities included youth-led campaigns, afterschool and summer programs, educational workshops, and mutual aid programs. All PSU campaigns were informed by the Student Bill of Rights, which unites a range of student demands for a safe, healthy, and engaging education. After several years of litigation, an agreement was reached in the Cook v. McKee (formerly Cook v. Raimondo) case to improve civics education in Rhode Island. PSU made progress on the Counselors Not Cops (CNC) campaign, which calls for the removal of school resource officers (SROs) and increased access to mental health resources and support staff in school. PSU also supported efforts to implement accurate, culturally relevant curriculum in the district through the ethnic studies campaign
