REPRESENTATION INCLUDES ADMINISTRATIVE ADVOCACY BEFORE THE PRISONER REVIEW BOARD, DEPARTMENT OF CORRECTIONS, AND GOVERNOR'S OFFICE, AS WELL AS LITIGATION IN COURT.
