Another key program DO focused on in 2022 was the further establishment of the Malawi Field Office (MFO). The MFO allows DO to be more available to meet with missionaries, non-governmental organizations (NGOs), community leaders, and government officials to work toward policy change, Gospel outreach, and appropriate technology implementation that will have generational impact in the communities where we work.
