AS A NATIONAL NONPROFIT ORGANIZATION, THE FOUNDATION'S MISSION IS TO EDUCATE AND EMPOWER YOUTH AND ADULTS TO PREVENT VIOLENCE IN SCHOOLS, HOMES, AND COMMUNITIES. AS CREATORS OF THE LIFESAVING, EVIDENCE INFORMED "KNOW THE SIGNS" PREVENTION PROGRAMS, THE FOUNDATION TEACHES THE WARNING SIGNS OF SOMEONE WHO MAY BE IN CRISIS, SOCIALLY ISOLATED, OR AT-RISK OF HURTING THEMSELVES OR OTHERS AND HOW TO GET HELP.
