ACC AND ITS MEMBERS CONTINUE TO SUPPORT THE CREDIT NEEDS OF SMALL BUSINESSES IN APPALACHIA. FROM 2015, WHEN ACC FIRST BEGAN LENDING, THROUGH DECEMBER 31, 2022, MEMBERS REPORTED THAT THEY HAD USED ACC PROCEEDS TO MAKE 121 SMALL BUSINESS LOANS RANGING FROM \$10,000 TO \$3 MILLION, 78 (OR 64%) OF WHICH WERE TO MINORITY- OR WOMEN-OWNED BUSINESSES. MEMBERS REPORT THAT THE SMALL BUSINESSES THEY FINANCED HAVE HELPED TO CREATE OR RETAIN 2,736 JOBS, 43 PERCENT OF WHICH ARE OCCUPIED BY LOW-INCOME PEOPLE.
