OUR 7 NON-ACCREDITED SITES IN 5 COUNTRIES (UGANDA, KENYA, TANZANIA, RWANDA, AND BURUNDI) TRAINED OVER 500 STUDENTS IN THEOLOGY. 2) WE HOSTED OUR FIRST-EVER NON-ACCREDITED CLASSES AT THE NEWLY PURCHASED CAMPUS IN KIGALI, RWANDA. 3) OUR PILOT "BRIDGING PROGRAMS" WERE RECOGNIZED BY THE NATIONAL COUNCIL FOR HIGHER EDUCATION IN UGANDA TO HELP FOREIGN PASTORS AND OTHER PASTORS WHO NEVER FINISHED HIGH SCHOOL TO HAVE A CHANCE TO START IN HIGHER EDUCATION. 4) WE STARTED A GRANT AND MENTORING PROGRAM FOR A NEW CHURCH PLANT LED BY TBI STUDENTS IN EASTERN UGANDA. 5) WE LAUNCHED THE TRINITY NETWORK FOR CHURCH PLANTING AND CHURCH HEALTH TO PROVIDE RESOURCES, OPPORTUNITIES, AND CONTINUING EDUCATION FOR OUR GRADUATES.
