During 2022 we gave an estimated 130 private tours of the sanctuary to educate the public about wolf-dog behavior and care requirements and to discourage the public from adopting wolf-dogs from backyard breeders. The organization also assisted in the rescue and placement of unwanted wolf-dogs and provided consultation to individuals and organizations with the aim to reduce the preventable euthanasia of wolf-dogs and dogs misidentified as wolf-dogs.
