MEMBERS ARE ACTIVE IMPACT INVESTORS, AND MANY ARE THOUGHT LEADERS IN THE FIELD. TONIIC FACILITATED 287 GLOBAL CALLS, WEBINARS, AND EVENTS WITH MORE THAN 2,485 ATTENDEES TO PROMOTE IMPACT INVESTING AND ADDRESS CHALLENGES THAT MEMBERS AND THE FIELD FACE IN CAPITAL DEPLOYMENT. TONIIC PUBLISHES PERIODIC REPORTS ANALYZING COLLECTED DATA, AND SHARES ANONYMIZED DATA WITH AN ACADEMIC RESEARCH CONSORTIUM LED BY THE CENTER FOR SUSTAINABLE PRIVATE WEALTH AT THE UNIVERSITY OF ZURICH. AS PART OF THE T100 PROJECT, TONIIC LAUNCHED TRACER, AN IMPACT PORTFOLIO MANAGEMENT PLATFORM DESIGNED TO FACILITATE DATA COLLECTION FOR THE T100 PROJECT.
