BY EMPOWERING, CONNECTING, AND ACTIVATING LEADERS ACROSS THE CLIMATE MOVEMENT, BFP IS HELPING TO BUILD A SOCIAL MOVEMENT THAT CAN CONFRONT THE FOSSIL FUEL INDUSTRY AND SHOW OUR LEADERS THAT WE DEMAND BOLD ACTION IN THIS TIME OF CRISIS. OUR THREE PROGRAMS ARE 350 MASSACHUSETTS, COMMUNITIES RESPONDING TO EXTREME WEATHER ("CREW") AND POLLUTERS PAY. IN ADDITION, DURING 2021, THE BETTER FUTURE PROJECT ACTED AS THE STATE CONVENING ORGANIZATION ("SCO") IN RELATIONSHIP TO THE GREEN NEW DEAL NETWORK ("GNDN"), AND IN THAT ROLE AS THE SCO CONVENED A COALITION OF ORGANIZATIONS WORKING TOWARD THE GOALS OF A GREEN NEW DEAL ADDRESSING CLIMATE CHANGE, CREATING JOBS, AND ADVANCING JUSTICE. THE COALITION FORMED IN SERVICE OF THIS GRANT IS KNOWN AS THE MASS RENEWS ALLIANCE. 350 MASSACHUSETTS: 350 MASSACHUSETTS ("350 MASS") IS OUR STATEWIDE CLIMATE-ACTION VOLUNTEER NETWORK. 350 MASS EDUCATES THE PUBLIC AROUND KEY CLIMATE AND ENERGY POLICIES, INCLUDING THE NEED TO CENTER EQUITY AND JUSTICE AS CORE PARTS OF CLIMATE SOLUTIONS. VOLUNTEER LEADERS IN OUR 17 NODES OF 350 MASS HELP ACHIEVE LOCAL POLICY VICTORIES IN THEIR COMMUNITIES.
