THE NATIONAL GIRLS COLLABORATIVE PROVIDES A DIRECTORY OF GIRL-SERVING STEM PROGRAMS AND ALLOWS THOSE PROGRAMS TO BROADCAST THEIR ACTIVITY WITH EVENTS AND NEWS. THE CONNECTORY, OPERATED AND MANAGED BY THE NATIONAL GIRLS COLLABORATIVE, IS THE LARGEST DIRECTORY OF YOUTH-SERVING STEM PROGRAMS AND OPPORTUNITIES. THIS DATABASE, CONTAINING THOUSANDS OF PROGRAMS, MAKES IT SIMPLE FOR ORGANIZATIONS TO CONNECT WITH ONE ANOTHER, IS NAVIGABLE BY CAREGIVERS LOOKING FOR YOUTH STEM OPPORTUNITIES, AND OFFERS ENHANCED FUNCTIONALITY THROUGH LOCAL AND NATIONAL PARTNERSHIPS.
