THROUGHOUT 2022, WE HELD OUR ANNUAL CAMP LIVIN WEEKEND RETREAT FOR FAMILIES THAT HAVE SUFFERED A LOSS TO SUICIDE. WE ALSO HELD OUR ANNUAL LIVIN MUSIC FESTIVAL, WHICH CREATES QUALITY ENGAGEMENT AND OUTREACH WITHIN THE COMMUNITY, ULTIMATELY STARTING MORE CONVERSATIONS ABOUT MENTAL ILLNESS WITH THE GOAL OF PREVENTING SUICIDE. IN ADDITION TO THESE TWO ANNUAL EVENTS, THE LIVIN FOUNDATION AWARDED FINANCIAL GRANTS THROUGH OUR GRANT COMMITTEE, TO INDIVIDUALS AND FAMILIES IN NEED WITHIN OUR COMMUNITY, SPECIFICALLY SUFFERING FROM A MENTAL HEALTH NEED. WE ALSO CREATED AND DESIGNED A PROOF- OF-CONCEPT PITCH FOR A PROPOSED NEW MENTAL HEALTH SUPPORT PLATFORM WITH A HUMAN TOUCH CALLED LIVINCONNECTED.
