In 2022, this program evolved into Read & Rant. Read & Rant: A Plays In Progress Series is Athena Projects book club exploring plays written primarily by women. We read one to two unproduced scripts each month and typically meet every third Monday online via Zoom, to discuss the works. Learn what makes a good script, discuss how it affects us, and explore the ways it links to the larger world. This monthly free offering to the community aims to raise awareness of the under-representation of womens stories on stage and are led by professional Dramaturgs.

Athena Project curated a mobile art project using roving billboard trucks displaying visual artwork, musicians performing in pedicabs, and a mobile stage to showcase dancers, comedians, and spoken word artists at 3-4 stops along the way. We prioritized visiting underserved communities, providing access to the arts in spaces not traditionally reached, while committing to thoughtfully creating an inclusive environment through relationship building and intentional outreach to create a better experience for all involved.
