THIS PROGRAM ASSISTED CLIENTS WITH MULTIPLE SERVICES TO CONNECT THEM TO NECESSARY RESOURCES SUCH AS ENERGY ASSISTANCE PROGRAMS, EMPLOYMENT, HOUSING, FOOD PROGRAMS AND OTHER MEANS OF ASSISTANCE TO ENSURE CLIENTS BECOME MORE STABLE. CRC STAFF ALSO PROVIDED 438.25 HOURS OF DIRECT CONTACT WITH CLIENTS AND ASSISTED THEM BY PROVIDING 347 HOURS OF ADVOCACY WORK WITH LANDLORDS AND OTHER AGENCIES ON THEIR BEHALF.
