TODAY, THE LAWYERS' COMMITTEE IS A NONPARTISAN, NONPROFIT ORGANIZATION WHOSE MISSION IS TO USE LEGAL ADVOCACY TO ACHIEVE RACIAL JUSTICE, FIGHTING INSIDE AND OUTSIDE THE COURTS TO ENSURE THAT BLACK PEOPLE AND OTHER PEOPLE OF COLOR HAVE THE VOICE, OPPORTUNITY, AND POWER TO MAKE THE PROMISES OF OUR DEMOCRACY REAL. THE LAWYERS' COMMITTEE CONTINUES TO MARSHAL THE RESOURCES OF THE PRIVATE BAR TO ADVANCE ITS MISSION.
