WHILE THE IRS DOES NOT REQUIRE PRIOR APPROVAL OF THE 990 BY THE BOARD AND THERE IS NO LEGAL PENALTY FOR THE FAILURE OF A BOARD TO DO SO, WOODSON STAFF AND THE FINANCE COMMITTEE FEEL THESE QUESTIONS POINT OUT THE NEED FOR THE ENTIRE BOARD TO BE CONVERSANT IN THE INFORMATION PRESENTED IN THE FORM 990. AS SUCH, THE BOARD OF DIRECTORS FIND IT IS A VITAL AND FIDUCIARY DUTY OF THE ORGANIZATION'S ENTIRE BOARD TO BE INVOLVED IN THE PROCESS WITH RESPECT TO THE GOVERNANCE AND OPERATIONAL QUESTIONS RAISED BY THE FORM AND TO BE INVOLVED IN THE APPROVAL OF THE FORM 990 BEFORE IT IS FILED WITH THE IRS.
