THE EXECUTIVE COMMITTEE, IN CONSULTATION WITH THE BOARD OF DIRECTORS, PROPOSES CHANGES IN COMPENSATION FOR THE EXECUTIVE DIRECTOR BASED ON PERFORMANCE OUTCOMES TO THE BOARD CHAIR FOR APPROVAL BY THE BOARD OF DIRECTORS DURING A BUDGET APPROVAL PROCESS. ANY INCREASES IN COMPENSATION FOR STAFF ARE PROPOSED BY THE EXECUTIVE COMMITTEE AND APPROVED BY THE BOARD OF DIRECTORS.
