WE HARNESSSED THE POWER OF SOCIAL MEDIA, VIDEO CONTENT, TRADITIONAL MEDIA, AND CELEBRITY PARTNERSHIPS, ALL IN SUPPORT OF OUR CAMPAIGNS TO INCREASE LEGAL PROTECTIONS AND CORPORATE POLICIES FOR FARMED ANIMALS. THE SOCIAL MEDIA TEAM GARNERED 19 MILLION ONLINE VIDEO VIEWS, 110 MILLION IMPRESSIONS, AND NEARLY 1.5 MILLION CHOOSEVEG AND MERCY FOR ANIMALS BLOG VIEWS. IN THE U.S., WE EXPOSED AN ALDI CHICKEN SUPPLIER, PAVING THE WAY FOR OUR CAMPAIGN ASKING THE SUPERMARKET CHAIN TO MAKE CHICKEN WELFARE IMPROVEMENTS.
