Working Bikes acquires donated or discarded bicycles and gives those bicycles new homes. The organization donates bicycles internationally; fixes bicycles to donate and sell locally; and educates the public in bicycle repair, safety and reuse, while supporting healthy cycling.

In 2022, Working Bikes collected 10,894 used bicycles with the help of supported recycling fairs, and provided information on safe-riding, basic bike repair, and recycling at dozens of community events. Countless individuals and entities including bike shops, property companies and police departments were donation drop off partners for unwanted bicycles to be repurposed by Working Bikes. Hundreds of volunteers donated thousands of hours to Working Bikes in 2022 and facilitated the donation of 7,141 bikes (16 shipping containers) of used bicycles to our international partners in Africa and Central America. Volunteers and staff also repaired and distributed 1,067 bicycles to local Chicago organizations and individuals and donated 554 bikes to partners around the Midwest, who repaired the bikes and distributed them to their communities.
