NATIONS MINISTRY HELPS REFUGEE FAMILIES BECOME GENERATIONALLY SUCCESSFUL THROUGH INTENSIVE SERVICES PROVIDED TO YOUTH THROUGH AFTER-SCHOOL AND SUMMER LITERACY PROGRAMS, SOCIAL-EMOTIONAL LEARNING SUPPORTS, A SEVEN-WEEK SUMMER READING PROGRAM, CASE MANAGEMENT, AND PARENT WORKSHOPS ON EDUCATION OPPORTUNITIES. THIS YEAR THE PROGRAM SERVED A TOTAL OF 154 CHILDREN FROM 18 ETHNIC IDENTITIES.
