Employment - GIENC provided employment opportunities to 984 people through its 42 employment program centers serving 19 counties in eastern North Carolina. Over 7200 hours of professional development was provided to employees in eastern North Carolina. Employees within the employment program earned a benefit and wage package exceeding \$22 per hour in 2022.

Education - GIENC provided educational opportunities to over 19,000 learners within local and regional communities throughout eastern North Carolina via its online learning platform focusing on math, English, and technology. Over 14,000 school kits were distributed to children in Tier 1 county school systems. One Science, Technology, Engineering, Arts, and Math (STEAM) lad was designed and built for a local youth-based organization. GIENC's accredited Accelerated Career Training program graduated 21 individuals who were awarded over \$5,000 in stipends upon graduation.

Life Enrichment - GIENC has provided over \$1,200,000 in grants to local and regional nonprofits through its Agency Empowerment Program. GIENC's Volunteer center hosted community projects resulting in over 2,000 hours of volunteer engagement with local communities.
