THE ATLANTA PRIDE FESTIVAL AND PARADE PROVIDED A PLACE FOR HUNDREDS OF THOUSANDS OF PEOPLE FROM ACROSS THE STATE, REGION, AND COUNTRY TO CONNECT WITH ONE ANOTHER AND WITH THE NECESSARY SERVICES FROM LGBTQ+ SERVING ORGANIZATIONS. THE ATLANTA PRIDE COMMITTEE'S (APC) COMMUNITY REINVESTMENT GRANTS (CRG) PROVIDE FUNDING AND RESOURCES TO FULLOW COMMUNITY ORGANIZATIONS THAT ALIGN WITH THEIR MISSION AND STRATEGIC GOALS. THE APC ALSO CONTINUED TO PARTNER WITH MANY OTHER LGBTQ+ SERVING ORGANIZATIONS ON SPECIALIZED PROGRAMMING THROUGHOUT THE YEAR TO INFORM, EDUCATE, AND LIFT UP THE COMMUNITY.
