NC CONSERVATION NETWORK SUPPORTS, TRAINS, AND COORDINATES DIVERSE GROUPS AND DIRECTLY ADVOCATES TO ACHIEVE EQUITABLE AND SUSTAINABLE SOLUTIONS FOR OUR ENVIRONMENT. IN 2022, OUR GRASSROOTS BASE OF OVER 60,000 EMAIL ACTIVISTS AND OVER 25,000 TEXT ALERT SUBSCRIBERS SENT EMAILS AND MADE PHONE CALLS TO THEIR DECISION-MAKERS AND PARTICIPATED IN EVENTS ON ISSUES SUCH AS CLIMATE CHANGE, FOREVER CHEMICALS IN OUR WATER, AND CLEAN ENERGY. THIS RESULTED IN OVER 37,000 ACTIONS TO SUPPORT OUR ENVIRONMENT. NC CONSERVATION NETWORK WORKS TO INCREASE AWARENESS OF-AND PROVIDE WAYS TO TAKE ACTION ON-KEY ISSUES IMPACTING THE HEALTH OF OUR STATE THROUGH SOCIAL MEDIA. NC CONSERVATION NETWORK WORKS TO CONTINUALLY SUPPORT OUR AFFILIATES-OVER 60 ENVIRONMENTAL, COMMUNITY, AND ENVIRONMENTAL JUSTICE ORGANIZATIONS.
