Eleven (11) units will be demolished, including one unit that is leased from the City of Sanibel. The CHR complex housing ten (10) of eleven (11) units to be demolished had a mortgage balance at September 30, 2022 of \$496,789 and a current mortgage balance of \$472,000. The mortgage holder has provided CHR with options to pay off the loan, enter into an interest only arrangement, or keep the loan as is. CHR is still considering which option is optimal considering financial impact and cash flows.
