The Organization offered free legal support was offered to 4,287 people on housing issues, particularly in mortgages, rents, and disasters. Also, free legal information was offered to more than 2 million people through the webpage Ayudalegalpr.org. Guides and processes were transformed to guarantee equitable access to recovery funds, at the local level and even at the federal level. The impact of the development created by ALPR to change FEMA's ownership requirements has an impact throughout the United States since September 2021. Participated in public hearings, forums and advocacy spaces such as the United States Congress. Designed and participated in educational and advocacy forums with international participation, such as the Roof is a Right Meeting and the Third Meeting for Just Recovery. Strengthening of the Dignified Rentals program, which defends impoverished people from evictions due to non-payment. Launched a campaign on COVID-19 and zero evictions during the pandemic
