The organization operated the following programs for the year ended June 30, 2022: St. James: The Louisiana Bucket Brigade supports the people of St. James Parish in their pursuit of clean air, clean water and clean soil within the parish. We provide technical assistance in the areas of organizing and media and organizational development. As part of that effort, The Louisiana Bucket Brigade assists the group Rise St. James in their organizational development, including program planning, budgeting, fundraising, administrative and financial management. With our support, this group has helped to prevent additional air pollution in St. James Parish. They have raised their own funds, thus increasing their budget size and managed their operating budget. Movement Building: The Louisiana Bucket Brigade provide technical support (cartography, event planning, research) to partner groups so that they have the information and resource they need to engage their neighbors, enforcement agencies, journalists and other collaborators. With our support, these groups have seen an increase in their budget size and organizational capacity. Community Support: Our primary partnership is in St. James, but we also provide media and organizing support to other communities as necessary.
