CIS-SCT SERVED SEVEN SCHOOL DISTRICTS AND PROVIDED 4,448 STUDENTS WITH INTENSIVE, INDIVIDUALIZED, HOLISTIC SERVICES. IN ADDITION, CIS-SCT PROVIDED TWO OR MORE SERVICES TO OVER 39,100 STUDENTS. CIS-SCT ACCOMPLISHED THIS IN COLLABORATION WITH 493 VOLUNTEERS PROVIDING 17,897 HOURS OF SERVICES AND OVER 464 COMMUNITY PARTNERSHIPS TO MEET THE NEEDS OF STUDENTS AND THEIR FAMILIES.
