IN ADDITION, ECA ENGAGED OVER 5,000 COMMUNITY MEMBERS OF ALL AGES IN FREE OR LOW-COST OUTREACH PROGRAMS, INCLUDING EDUCATION MATINES FOR SCHOOL GROUPS, ARTIST RESIDENCIES AND OUTREACH, DEMENTIA-INCLUSIVE SERIES, FAMILY PROGRAMMING AND SUMMER ARTS ENRICHMENT CAMPS.
