Each choir rehearses once a week and concludes the session with free community concerts. In the summer, we offer an 8-week Summer Rocks session, and the concerts include a live 4-piece band made up of some of Chicagos finest professional rock musicians.In 2022, these sessions were once again offered in person once the pandemic restrictions lifted. Nearly 350 choristers participated in the programs.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$) Continued from 4a above: Providing a continuum of services as people age, we offer the Good Memories Choir, which serves people with early-stage memory loss and their care partners, rehearsing and performing with a group of dedicated singing volunteers. One of our locations is a combination of the Sounds Good and Good Memories models: this is the Dementia-Friendly Evanston Choir.We continue weekly virtual, free sing-alongs that began in 2021, serving over a hundred singers.
