GRCPAC is a very small organization heavily dependent on volunteer directors. Paula G. Barta, the Treasurer, was responsible not only for preparing the operating financial statements and tax forms, but also monthly management reports, annual budgets and SVOG grant compliance. On September 1, 2023, Paula's husband of 44 years died. She managed to keep up with current reporting, sales tax, 2024 budget development, and SVOG grant compliance, but she dropped the ball on the 2022 tax return. This has never happened before and will not happen again. While no one could complete 2022 for her, an outside accountant has been engaged to prepare the 2023 informational return which will be filed timely. We hope you will find this cause for late filing reasonable.
