THIS CENTER UTILIZES BOTH QUALITATIVE AND QUANTITATIVE EVIDENCE TO ADVANCE SYSTEM DESIGN, WITH A PRIMARY FOCUS ON INCORPORATING THE REAL-WORLD EXPERIENCES OF YOUTH IN FOSTER CARE. THROUGH A HOLISTIC APPROACH THAT COMBINES PARTICIPATORY RESEARCH, DATA ANALYSIS, TOOLS AND TECHNOLOGY UTILIZATION, COMMUNITY BUILDING, THOUGHT LEADERSHIP, AND PROXIMATE POLICY, THE CENTER FOR LIVED EXPERIENCE SYSTEMATICALLY INTEGRATES LIVED EXPERIENCE INTO ALL FACETS OF CHILD WELFARE RESEARCH, POLICY, AND PRACTICE.
