We also had a booth at HSUS's Animal Care Expo to help us recruit more projects at a total cost of 1,423.74. Additional program expenses include: Maintenance of our website 825.7, State Registrations 555, Bank Charges of 15, Accounting 59.5, and Postage to send Tax Filings 42.17.
