IN PARTNERSHIP WITH HOUSING AND URBAN DEVELOPMENT, HAWAII RISE FOUNDATION HAS BEEN ABLE TO ASSIST VICTIMS OF DOMESTIC VIOLENCE ABUSE WITH THEIR RENTAL EXPENSES TO HELP GET THEM BACK ON THEIR FEET AND HAVE A SAFE PLACE TO CALL HOME FOR A LONG PERIOD OF TIME. THIS PAYS FOR SECURITY DEPOSIT, RENTAL ASSISTANCE, UTILITY BILLS AND HELPS TO PROVIDE SUPPORTIVE SERVICES TO THE CLIENT THROUGH THERAPY AND COUNSELING. VICTIMS MUST EITHER HAVE A JOB OR BE GOING TO SCHOOL, AND THEIR CHILDREN MUST BE IN SCHOOL TO RECEIVE THESE SERVICES. 80% OF THE DOMESTIC VIOLENCE VICTIMS WE HOUSE, SUPPORT AND ASSIST ARE NATIVE HAWAIIAN WOMEN.

KULEANA HEALTH IS A GRANT THAT IS CURRENTLY HELPING TO FUND FINANCIAL LITERACY ON THE BIG ISLAND. IN PARTNERSHIP WITH KA PA'ALANA PARTNERS IN DEVELOPMENT, WE HAVE BEEN OFFERING TRAUMA INFORMED CARE WORKSHOPS TO OUR PARTNER LEADERS AND PROVIDING FREE COVID TEST KITS TO COMMUNITY MEMBERS, SO PEOPLE HAVE ACCESSIBLE CARE AND RESOURCES. WE HAVE GIVEN OVER 5,000 COVID TEST KITS FOR FREE IN OUR COMMUNITY, 90% OF THE PEOPLE RECEIVING THEM ARE NATIVE HAWAIIAN.

WE WORK WITH THE HAWAII NATIONAL GUARD YOUTH CHALLENGE ACADEMY TO PROVIDE TRAINING AND WORKSHOPS TO TEACH AND ENGAGE THE CADETS ON PROFESSIONAL DEVELOPMENT SKILLS SUCH AS "HOW TO BUILD A RESUME", "MOCK INTERVIEWS", "FINANCIAL WELLNESS (IN PARTNERSHIP WITH HFSFCU)", "HEALTHY RELATIONSHIPS", "VISION BOARD BUILDING- AND CPR CERTIFICATIONS. THROUGH KAMEHAMEHA SCHOOLS, WE ARE ABLE TO PROVIDE FREE PERSONAL AND PROFESSIONAL DEVELOPMENT CLASSES/WORKSHOPS TO THE HAWAII NATIONAL GUARD YOUTH CHALLENGE ACADEMY CADETS & AT-RISK/DISADVANTAGED YOUTH. MANY PROFESSIONALS HAVE HELPED US TO PUT ON THESE WORKSHOPS INCLUDING FORMER MISS HAWAII(S) RAECEEN SATELE, COURTNEY CHOY AND FORMER CONGRESSMAN KAIALI'I KAHELE. 80% OF THE STUDENTS WE TEACH THESE WORKSHOPS TO ARE NATIVE HAWAIIAN.

TOGETHER WE CAN HAWAII RISE FOUNDATION HAS PARTNERED WITH OK FARMS TO PROVIDE COMMUNITY SUPPORTED AGRICULTURE (CSA) BOXES TO THE KAPUNA IN VARIOUS HAWAI'I ISLAND COMMUNITIES. EACH BOX IS FILLED WITH A VARIETY OF SEASONAL FRUITS, VEGETABLES, AND STARCHES, ALL GROWN LOCALLY HERE IN HAWAI'I. THROUGH THIS PROGRAM, WE WILL BE ABLE TO SERVE 680 DIFFERENT KAPUNA ALL AROUND HAWAI'I ISLAND, AS WELL AS SUPPORT OUR LOCAL AGRICULTURE COMMUNITY SIMULTANEOUSLY. 18 DIFFERENT LOCAL FARMS ARE SUPPORTED THROUGH THIS PROGRAM. MALAMA I NA KEIKI BACKPACK HAWAII RISE PROVIDED FOOD IN TOTAL TO 1600 CHILDREN OVER 11 MONTHS. THESE MEAL PACKS INCLUDED THE WEEKLY FRUIT AND VEGETABLES FROM THE CHURCH ALONG WITH DONATIONS QUARTERLY FROM HONAUNAU MARKET. THIS HELPED SUPPLEMENT FOOD FOR OUR FAMILIES ON THE WEEKEND SO OUR KIDS WOULD HAVE ADDITIONAL FOOD IN THE HOME WHILE SCHOOL WAS OUT. KEIKI TOURISM AND HOSPITALITY KULEANA PROJECT KAMEHAMEHA SCHOOLS HAWAII KULA KAUWELA 5TH GRADE STUDENTS PROGRAM TITLED: "HO'OKIPA 808" OLA KA 'AINA, OLA KE KANAKA WHEN THE LAND IS WELL, SO ARE ITS PEOPLE WHAT IS THE HEALTH OF OUR SPACES? STUDENTS RESEARCH THE TRENDS AND IMPACTS OF TOURISM ON OUR AINA, ECONOMY, COMMUNITY, AND HOST CULTURE. IS HAWAI'I A PLAYGROUND FOR OTHERS? AS KEIKI ECONOMISTS AND FUTURISTS, HAUMANA DEBATE DIFFERENT PERSPECTIVES AND TAKE RESPONSIBLE ACTION.
