HISTORICALLY, GRANTS HAVE SUPPORTED COMMUNITY ORGANIZING, LEADERSHIP DEVELOPMENT, DIRECT ADVOCACY, JOURNALISM, NARRATIVE CHANGE, PROSECUTOR ACCOUNTABILITY, AND POLICY REFORM. WE PRIORITIZE FUNDING TO DIRECTLY IMPACTED LEADERS, AND A LARGE MAJORITY OF OUR FUNDING GOES TO ORGANIZATIONS LED BY PEOPLE OF COLOR.
