The Escalator Award program provides institutional funding to support and advance women in cardiology by providing training, research grants, mentoring and networking support. The 2022 program awarded 9 grants, totaling \$273,000.

4b (Code:) (Expenses \$ 260,748 including grants of \$ 0) (Revenue \$ 0)

The CLIMB program provides clinical skills training to women in areas of medicine where they are highly underrepresented. Distinguishing features of the program include small group sessions led by world renown experts, and focused attention on networking among all attendees and sponsors. The 2022 virtual program enrolled over 120 women into 9 distinct learning tracks covering 5 topic areas.

4c (Code:) (Expenses \$ 112,721 including grants of \$ 0) (Revenue \$ 0)

Women As One's Talent Directory collects professional profiles on women physicians who voluntarily agree to be part of this free program. The Talent Directory program allows the organization to use various profile fields to match registrants with ongoing professional opportunities such as speaking engagements, advisory board participation, and research projects. There are currently nearly 1,900 women registered in the Talent Directory from 94 different countries.

Publications: In connection with the work Women as One does to promote gender equity in medicine, the organization assembles working groups to develop research and publish manuscripts in major academic medical journals. 2022's program focused on gathering research and drafting publications on the topic of academic publishing.

Equity Programs: Women as One focused resources on providing education and driving awareness to issues that negatively impact women in medicine. Resources are found on Women as One's website, partner webinars in multiple geographies and template distribution.
