What is the organization's primary exempt purpose?
 The Primary Aldosteronism Foundation is committed to advancing standards of care for affected patients through proper diagnosis and treatment, actionable research and inclusive collaboration. To achieve its mission, the Foundation focuses on areas at the intersection of research, diagnosis, treatment and patient-oriented solutions.

28 Primary Aldosteronism Roundtable and Summit. The Foundation has identified 11 factors across the healthcare sector that are responsible for the lack of diagnosis and treatment for PA. We've held consultations with the leadership of some 45 organizations responsible for the factors, including: ASN, ACC, Endocrine Society, AAFP, ACP, AAES, SIRWEB, AHA, CDC, FDA, NIH, academic institutions, healthcare systems and payers, laboratories, pharmaceutical industries. On June 29, 2023, the Foundation convened these stakeholders in a "Call to Action to Diagnose and Treat Primary Aldosteronism" which included 34 high-profile executives from these groups. This event led to the creation of a multi-stakeholder "PA Alliance" to improve standards of care of primary aldosteronism through collaborative work, which we announced in September.

29 Research and Innovation. Although discovered 60 years ago, the understanding of primary aldosteronism and its pathogenesis remains fragmented, and 95% of patients are neither diagnosed nor treated despite high disease prevalence (up to 13.5% of the population). In our mission to improve standards for patients with PA we are leading, coordinating, or participating in multiple initiatives. 1) Clinical Guidelines. In November 2022, the Primary Aldosteronism Foundation was invited to participate in the revision of the clinical practice guidelines. One of the Foundation's Co-Founders represents patients at the monthly meetings of the review panel. The revision is coordinated by the Endocrine Society, and its completion is anticipated by 2025. 2) Availability of Care. As of November 2022, the Society of Interventional Radiology has committed to providing an inventory of adrenal venous sampling capacity in the US. The American Association of Endocrine Surgeons has joined in the effort and will overlay the data with surgical capacity. The aim of this intervention is to remediate gaps by developing a regionally balanced increase in availability of care and establishing a pathway to capacity for medical centers (e.g., formal accreditation). 3) Barriers to Diagnosis and Care. Formal investigation of the causes of underdiagnosis and misdiagnosis by primary care physicians and specialists has never been conducted. Understanding of clinical and therapeutic inertia is essential to inform the co-creation with providers of effective interventions to improve standards of care at scale. Together with the Foundation, clinical researchers from Yale, Vanderbilt, Monash University, and the University of Calgary are collaborating to fill this important knowledge gap. Combining expertise in implementation science research, primary care, endocrinology, cardiology, and nephrology, they will publish an opinion paper in early 2023. Preliminary results of the study are expected later in the year and will be submitted to peer review journals. 4) Patient Discovery. We are participating in the development of a predictive modeling tool leveraging artificial intelligence to identify affected patients and those at high risk for the disease in collaboration with Atomo and the University of Pennsylvania. 5) Availability of Care. The Foundation is working with industry leaders to translate advances into diagnostic and therapeutic solutions through the support of multiple clinical trials (CinCor, Mineralys, PhaseBio, KBP Biosciences, FDA). Our long-term goal is the availability of new FDA-approved drugs to treat primary aldosteronism. 8) Patient Support. The Foundation has compiled and is maintaining an online database of >780 academic articles published on primary aldosteronism. 9) Research. The Foundation is participating as an Associate Investigator on various multi-year grant applications.

30 Education on Primary Aldosteronism for Patients, Providers, and Stakeholders. The near absence of diagnosis and treatment of primary aldosteronism is in part due to a lack of education and the misconception that the disease is rare. The Foundation is addressing this area by: 1) Developing and maintaining an educational website on the disease with up-to-date information on diagnosis, treatment, research, and patient support with some 95 educational pages and over 780 reference articles in a searchable database. It has between 4-5K visitors each month from more than 150 countries worldwide, and it is one of the top sites listed by search engines about the disease. 2) We developed and maintain multiple databases to help patients find experienced and skilled treatment through carefully vetted lists of over 200 specialist physicians, 39 centers of excellence, 22 certified hypertension centers, and key information on all active and past clinical trials. 3) We continue to build partnerships with relevant institutions and organizations (FH Foundation, T1D Exchange, National Kidney Foundation, AHA, CDC, NADF, WHL, American Adrenal Association). 4) Moderating two online support groups dedicated to primary aldosteronism, and providing answers to patient questions through email and phone. 5) Publishing educational fact sheets for patients and providers. 6) Using Twitter and other social media to promote awareness of the disease. 7) Collecting and editing stories from patients and publishing them to our website to inform others about the challenges of diagnosis and treatment. 8) Working with a group in Australia on the development of our first international charter as part of our worldwide mission. 9) Collecting and tracking signatures to our Open Letter in support of our efforts through our website. Other funding: In addition to cash donations, the Foundation received another \$1,700 in in-kind service grants to host and maintain our website.
